Please quote your lowest rates (Inclusive of all taxes) for the enquiry for “Supply and Installation of 02 Nos. of Desktop Computers, 03 Nos. All in one Printer and 01 No. of Printer for EHV (O&M) Circle, Amravati”, as per MSETCL rules on terms & conditions given below. The bidders should submit their sealed and super scribed quotation by post or by hand delivery only, so as to reach this office on or before Dt.07.04.2020 up to 13:00 Hrs. and same will be opened on Dt.07.04.2020, if possible. The quotations received on/after Dt.07.04.2020 after time 13:00 Hrs. will not be considered for bidding process and will not be opened for this enquiry. In case of hand delivery, Quotation should be handed over to receipt clerk of this office. MSETCL will not be responsible in any manner for the postal delay of any type.

TERMS AND CONDITIONS -

1. **Scope of work** – Supply and Installation of 02 Nos. of Desktop Computers, 03 Nos. All in one Printer and 01 No. of Printer should be as per enclosed specification only.
2. The offer/quoted rates in **Schedule ‘A’** should include all taxes (GST, etc.) & other charges such as packing, transportation, Freight & Insurance, Installation etc.
3. **Work Order is limited to Rs. 2 lakhs only.**
4. The rate should be quoted on firm quotation basis.
5. **Specification** - The Desktop Computer & All in one Printer & Scanner shall be supplied as per specification mentioned in enclosed Annexure-I.
6. Material not confirming to the specification shall be rejected.
7. Actual quantity of the work may be changed as per requirement.
8. **While submitting the quotation, please Specify Make, Model no of the material to be supplied.**
9. Supply of the items should be carried out at destination of EHV O&M Circle, Amravati.
10. Bidder should not submit ‘Conditional Quotation’. Such conditional offer shall be liable for rejection.
11. Validity period of offer should be not less than 90 days from the date of opening of offer.
12. **Taxes** - Rates should be quoted including all taxes, if any i.e. GST, etc.
13. **Work Completion period** – 3 days from date of receipt of work order.

14. **Payment** – The 100% payment will be released after successful installation of supplied Desktop Computer & Printer. No advance payment will be made for this work.
15. **Warranty** - 3 years (onsite warranty) from date of installation of Desktop Computer & 1 years (onsite warranty) from date of installation of Printers should be provided.
16. **Security Deposit** - The agency shall have to pay the prescribed Security Deposit amounting to 10% of the total value of the contract in the form of cash or D. D. of any nationalized / Schedule bank in the name of Superintending Engineer, EHV O&M Circle, Amravati payable at Amravati. The same will be refunded after the satisfactory completion of the work.
17. **Agreement** - In case order is placed, you will have to enter an agreement with MSETCL on bond paper, in the prescribed format. You have to execute the agreement as per the provisions of "Mumbai Mudrank Adhiniyam 1958, Clause No.34" with requisite stamp duty within seven days from the date of issue of order. You will have to enter into an Agreement with MSETCL for the above work and until such agreement is executed within MSETCL, the MSETCL shall not be liable to pay nor you shall be entitled to claim any amount due for payment if any under this contract. The cost of the stamp paper required shall be borne by you. The necessary documents, for the agreement should be completed in consultation with Executive Engineer (Adm), EHV O&M Circle, MSETCL, Amravati for the above work.
18. While submitting the offer, the following documents (Self attested Xerox copies) must be submitted.
 - i. Valid Shop Act Registration certificate, if any.
 - ii. PAN card
 - iii. GST Registration certificate, if applicable.
19. The quotations without the documents as enlisted above and certificates as per **Schedule 'B'** are likely to be rejected. The quotations should be properly sealed in envelope and super scribed with text "Enquiry for work of supply & installation of desktop computer & Printer for EHV O&M Circle, Amravati."
20. Quotations not complying with the requirements may not be considered.
