Sealed and super scribed quotations are invited from reputed registered, experienced contractor for providing the driver service for M.S.E.T.C.L.'s vehicle MH-50-142 &MH-50-144 (LMV- TATA SUMO-VICTA) at Telecom Subdivision,Kolhapur & Karad as detailed schedule 'A' enclosed herewith subject to the following terms and conditions.

- 1) The requirement of driver service is at the office of the Addnl.Executive Engr. Telecom S/Dn. Kolhapur & Karad.
- 2) The normal head quarter of the driver hence shall be Kolhapur & Karad and place of reporting for duties shall be intimated by the controlling office subsequently. Normally, the vehicle will be utilized for Satara, Sangli, Kolhapur, Ratnagiri, Sindhudurg and Goa district.
- 3) The driver should have valid permanent LMV driving licence for more than five years and preferably the public badge too.
- The agency should have Govt. labour contract license, independent PF and ESI Nos.
- 5) The agency should be preferably be engaged in the welfare of ex servicemen and providing gainful employment for them.
- 6) The period of contract is for one year from the date of placement of order or intimation.
- 7) Night halt charges shall be payable only if M.S.E.T.C.L.'s vehicle is required to be halted at any place other than the normal head quarter.
- 8) Preference will be given to ex servicemen, other things being equal.
- 9) Daily routines & other periodical maintenance of the vehicle should be looked after by the driver

- 14) Lubricating oil and diesel shall be supplied by M.S.E.T.C.L.

- Cost of spares and maintenance shall be borne by the M.S.E.T.C.L. fully. However if any damage is caused by the driver will fully and or due to negligence, 15) the cost of the same shall be recovered from you.
