- 8. The fuel (Diesel) charges to be borne by MSETCL with the condition that the vehicle should give minimum 8 Km / Ltr and manufacture of vehicle provided should not be prior to year 2015.
- 9. The responsibility of comprehensive insurance, PUC & RTO formalities will be with vehicle provider.
- 10. The period of vehicle will normally be one year or amount whichever exhausted from the date of engagement of vehicle, however if MSETCL vehicle is allotted by C.O. Mumbai then the hired vehicle will be discontinued by giving 15 days' notice period.
- 11.**Security Deposit:-** Security deposit i.e. 5% of order value to be paid within 7 days in terms of cash/DD to the office of the Executive Engineer, EHV O&M Division Nanded from the date of issue of order.
- 12. Payment will be effected as per monthly basis within reasonable period as per availability of funds.
