Please quote your lowest rates (Inclusive of all taxes) for the enquiry for "work of 1) carrying out detailed survey of railway 06 Nos. crossing locations in r/o railway diversion work of 220 KV Deoli Ghatodi line up to LILO point for 220 KV Yavatmal S/Stn and preparation of railway crossing drawings. 2) carrying out Reconnaissance survey of 220 KV Kalmeshwar-Warud DCDC line Phase-V (Loc no. 12A/0 to Gantry)", as per M.S.E.T.C.L. rules on the Schedule 'A' annexed herewith and terms and conditions given below. The bidders should submit their sealed and super scribed quotation, so as to reach this office on or before Dt.06.05.2020 up to 13:00 Hrs. and same will be opened on Dt. 06.05.2020 at 15.00 Hrs. onwards, if possible. In case of hand delivery, Quotation should be handed over to receipt clerk of this office. M.S.E.T.C.L. will not be responsible in any manner for the postal delay of any type.

TERMS AND CONDITIONS -

- 1. **Scope of work**: The said work should be carried out in accordance with the particulars and description enlisted in the enclosed **Schedule 'A'**.
- 2. The rates should be quoted on firm basis including T&P, vehicle, transportation charges etc. required for execution of work in all respect.
- 3. Work should be carried out as per approved drawings and standard specifications of MSETCL.
- 4. No advance payment will be made for this work.
- 5. Actual quantity of the work may be changed as per site conditions.
- 6. The work mentioned in this enquiry will be carried out at site of 220 KV Deoli Ghatodi line & 220 KV Kalmeshwar-Warud DCDC line Phase-V (Loc no. 12A/0 to Gantry).
- 7. Bidder should not submit 'Conditional Quotation'. Such conditional offer shall be liable for rejection.
- 8. All the transportation shall be arranged by agency. Transportation will not be provided by the MSETCL.
- 9. The bidders are required to submit scanned copies of following certificates
 - a) PAN, TAN etc.
 - b) GSTN Registration Certificate.
 - c) Agency has to submit the Certificate of Experience of having successfully completed similar works in Govt. organization / private sector duly signed by the officer not below the rank of Executive Engineer

or equivalent in case of Govt. works or from authorized authority of private sector, along with copies of agreement of work/work orders mentioned in the certificate.

- 10. All taxes will be applicable as per rule.
- 11. The rates should be quoted in figures as well as in words.
- 12. The agency shall have to pay the prescribe Security Deposit amounting to 5% of the total value of the contract in the form of cash or D. D. of any nationalized / Schedule bank in the name of Executive Engineer, EHV Projects Division, Amravati payable at Amravati. The same will be refunded to you after the satisfactorily completion of the work. SD will not be deducted from any bill.
- 13. MSETCL will not be responsible if any damage is occurred to the contractor's equipment's, T&P or any accident to contractor's labors/personnel during work execution. Also, MSETCL will not be responsible if any theft/loss of contractor's material is occurred.
- 14. Any kind of loss to the MSETCL's property observed during the course of execution of work, by contractor's labour due to wrong operation shall be recovered from the bills or any kind of payment to be made to contractor from MSETCL.
- 15. Income tax will be deducted as per prevailing rules from bills and a certificate to that effect will be issued to the contractor. All statutory deduction should be deducted from your bill as per applicable rate.
- 16. The work shall be completed within 01 month from the date of work order issued to agency, failure of such; penalty equal to ½% per delayed week subject to the maximum of 10% of the work order value will be levied.
- 17. In the case you fail to complete work fully and partly within stipulated time, the balance work will be got completed under your risk and cost from other agency at the prevailing rates and difference in cost will be recovered from your bill and security deposit in this case will be forfeited.
- 18. The work should be strictly carried out as per standard MSETCL specifications and up to the entire satisfaction of the Engineer-In charge.
- 19. The contractor will be abiding by the Rules and Regulations in force in respect of his employees and workmen under the Workmen's Compensation Act and the Contract Labor Act etc. He should be a registered contractor and documentary evidence of the same should be produced.
- 20. No "T&P" and labour will be provided by the MSETCL.
- 21. You should insure your labours and staff as per the rules and liability of the accident to them while working will be purely on you.
- 22. The quantities enumerated in attached schedule "A" are approximate and payment will be made against actual executed quantities.
- 23. The work should be guaranteed for the period of 01 year from the date of commissioning of the work. During this period if any defects arises in material and workmanship, those should be attended and rectified by you with free of cost immediately.
- 24. Agreement: -You have to execute the agreements as per the provision of "Mumbai Mudrank Adhiniyam 1958, clause no.34" with requisite stamp duty within 7 days from receipt of order. You will have to enter into an agreement with MSETCL for the above work & until such agreement is executed between MSETCL & Contractor, MSETCL shall not be liable to pay nor you shall be entitled for any amount due for put under this contract. The cost of stamp Paper requires shall be borne by you. The necessary documents, for the agreement should be completed in consultation with Executive Engineer, EHV Projects Division, Amravati.
- 25. The quotations without the documents as enlisted in Schedule 'A' are likely to be rejected. The quotations should be properly sealed and super scribed with the Envelopes "Enquiry for work of 1) carrying out detailed survey of railway 06 Nos. crossing locations in r/o railway diversion work of 220 KV Deoli Ghatodi line up to LILO point for 220 KV Yavatmal S/Stn and preparation of railway crossing drawings. 2) carrying out Reconnaissance survey of 220 KV Kalmeshwar-Warud DCDC line Phase-V (Loc no. 12A/0 to Gantry)."
- 26. Quotations not complying to the requirements and certificates enlisted in terms and conditions sr. no.09 may not be considered. Right to accept / reject any or all quotations or part thereof is reserved by the undersigned.

- 27. While submitting the offer, documents (Xerox copies) enlisted in terms and conditions sr. no.09 must be self-attested.
- 28. In case of difference opinion, about interpretation of terms & conditions between Owner/Agency & MSETCL, the decision of order placing authority will be final & binding on the Owner / Agency.
- 29. Validity of the offer should be minimum for three months from the date of opening of the quotations.
- 30. Idle charges for any reason will not be accepted.
- 31. In addition to above Company's General Terms and Conditions about the Work Contract will be applicable to this enquiry.
- 32. In case of any dispute regarding this contract, the jurisdiction of the court will be Amravati.
- 33. The above work shall be carried out under the supervision of Additional Executive, Engineer, EHV S&I S/Dn, Amravati.
- 34. The undersigned reserves the right to cancel the work partly/fully without assigning any reason.
