(Note : Considering the unfortunate situation occurred due to COVID 19 Virus, the Government of India has imposed lockdown w.e.f 23rd March 2020 which then further extended till 31 May 2020 all over the state, it is requested to send the Quotations through Email only.)

TERMS AND CONDITIONS:

- 1. Scope Of Work:**- Supply 3 nos of Digital Multi meters and 5 nos. of Clamp on meters at Testing Dn., Pune as per Schedule – A enclosed herewith
- 2. Period Of Contract:** The Period of contract will be one month (60 days) from date of issue of work order.
- 3. Security Deposit:** You have to remit, before execution of order, Security Deposit @ of 10 % of the total value of the order i.e. Rs. 9,912/- in this office in Cash/ by D.D. / B.G. / fixed deposit in nationalized or scheduled bank after acceptance of this order and amount of S.D. shall be refunded to you after successful completion of work if applied within six months from the date of completion of order along with no dues certificate from all contract basis employees.
- 4. Rate Validity:** The offer shall be valid for acceptance for a period of 120 days from the last date of submission of quotation.
- 5. Acceptance Of Enquiry:** The Company does not bind itself to accept the lowest or any bid neither will any reason be assigned for the rejection of any bid. It is also not binding on the Company to disclose any analysis report on Enquiry.
- 6. Discarded To Enquiry Conditions:** The Company reserves to itself the right to reject the Enquiry.
- 7. Work Completion Period:**- Work should be completed within 2 months from the date of issue of work order
- 8. Sample Approval:** Before finalization of purchase order for supply, Sample should be got approved by Executive Engineer Testing Division, Pune. In case of any deviation from **Schedule A** specification, material will be rejected and order will be issued to next lowest agency conforming to specifications.
- 09. Signing Of Contract:** **The contractor shall enter into an agreement of Rs. 500/- with the MSETCL within 30 days from the date of receipt of the work order.** Until the agreement is executed,

the MSETCL will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor.

10. Guarantee: - Guarantee of material i.e. Multi meters and Clamp meters supplied to MSETCL should be provided. Any defects developed during guarantee period should be rectified at the cost of contractor.

11. Penalty: If the work is not completed within stipulated period the penalty @ ½% per week as applicable subject to maximum 10% of the order value of work, will be levied. Loss to MSETCL property or equivalent etc. due to your negligence will be penalized & will be recovered from the bill.

12. Failure Of Execution Of Work: Work will have to be executed as per the instruction of Executive Engineer or his representative. For failure to execute the work as per given Schedule "A" against the order in full, within the stipulated period, the Company shall be at liberty, without further notice or reminder to the contractor to get the same work done on account of and at the risk of the contractor and the prefer a claim for the difference in price and for all expense whatsoever incurred in getting the said work done and the same shall be recovered from any payment due to the Contractor from bills or deposit .

13. In case the work is not executed partly or fully the balance work will be got carried out from some other agency even at higher rate and difference in cost will be recovered from your pending bill with the Company or Security Deposit will be forfeited in addition to above.

14. Submission Of Tax Invoice : The tax invoice should be submitted to the Office of Executive Engineer Testing Division Pune as per Schedule 'A'. After receipt of tax invoice , payment will be effected accordingly subject to availability of funds.

15. Right of acceptance/rejection: The undersigned reserves the right to accept or reject the order without assigning any reason thereof. The undersigned reserves the right to alter, modify or cancel the above order at any stage if found necessary.

16. Conditions of Contract: All General / Technical / Commercial terms & conditions of the contract of the Company are applicable to this contract & will be binding on you

17. In case of any dispute whatsoever, regarding interpretation of the terms and conditions, or quality, the decision of the Executive Engineer, Testing Division Pune will be final and binding on the contractor.

18. Income Tax : Income Tax will be deducted from the contractor's bill.

19. All other Standard Terms and conditions prescribed by M.S.E.T.C.L., regarding supply and work, which are not stated here, are also applicable to this contract.

20. Jurisdiction: All disputes, differences related to the tender contract shall be subject to the exclusive jurisdiction of Pune District Court.

21. Quality Of Work: Quality of material supplied should be strictly confirmed to our specification, otherwise it will be rejected and contractor has to redone the same at his cost and risk only.

22. The work carried out by the contractor if found defective due to bad workmanship, that should be redone by contractor free of cost, if reported.

23. The provision made in various Acts in force applicable to this contract is obligatory on the Contractor while executing the work.
