- 1. **Due Date:-** The quotation completes in all respect, duly sealed & super scribed should be submitted to this office on or before **Dtd. 26.05.2020 upto 18:00 Hrs** Positively.
- 2. E-quotation Fees:-Agency should have to pay Rs. 105/- (Rs. 100+5% GST) against E-enquiry Quotation Fees by cash to Circle Office Karad & copy of the money receipt should attached with the quotation this office.
- 3. Scope of work: As detailed in schedule' A'.
- 4. Estimated cost:- The estimated cost is limited upto Rs.02.00 Lakhs Only inclusive of all taxes.
