- 2) You will have to pay security deposit of 5% of the total amount of the order. This Security Deposit will be paid after completion of guarantee/warranty period.
- 3) Work shall be carried out as per Schedule 'A'
- 4) The right to reject any or all the bids is reserved by the undersigned.
- 5) Rates quoted shall be valid for the period of 30 days from date of opening.
- 6) 100% payment will be effected in reasonable time after satisfactory completion of work & submission of bills.
- 7) **Guarantee:-** Work carried out should be guaranteed for the period of one year from the date of completion of work.
