Term & Conditions -I

Special Conditions: Your offer should be submitted in two separate parts "Part I- Techno commercial bid" & "Part II-Price bid".

(A) Techno commercial bid (Part-I) (Qualifying criteria) :

The Tendered should upload the following digitally scan copies of original documents / certificates online under techno commercial bid in one pdf file.

Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website https://srmetender.mahatransco.in

Note :-Notwithstanding anything stated above, the purchaser's decision in this regards shall be final. The above qualifying requirements are available in the question format in the RFx. The bidder has to answer all the questions at the time of bidding and also the supporting documents as required above shall be uploaded by the bidder. The documents will require digital signature at the time of uploading to the SRM Portal, the bidder has to connect the digital signature key at the time of uploading the Qualifying documents / any attachment.

Commercial Bid (Price Bid):

Tendered should have to submit the rates in the SRM for each items as per the guidelines attached for participating in the RFx.

Note:- "The price Bid shall not be attached in the document format i.e. by preparing the price bid and by uploading / attaching the scan copy of the price Bid. The same will be not accepted" Contract.

First the Techno-Commercial bid will be opened online in respect of all the Tenders received. The commercial bid will be opened online in respect of those Tenderers who have submitted all digitally signed documents/certificates in Techno-Commercial bid as required in satisfactory manner & who are qualified. If any Deviation is observed in the Techno-Commercial bid, the same will be informed you on your registered Email ID in the SRM Portal. You have to submit the compliance / required documents against the same within the stipulated time.

Note :- The Techno-Commercial Bid Documents and the Price Bids for the other bidders participated in the RFx can be viewed by you if required for limited time from the opening of the respective bids.

- A. Right to cancel/alteration any or all the tender offers without assigning any reason thereof is reserved by the undersigned.
- **B.** The scope covers for the providing various consumables items for pre monsoon maintenance at under 400kV R.S. Dn. for the year 2020-21.The rates shall be quoted in the SRM System as per the guidelines attached with the Tender document. The Schedule can be downloaded by the bidder by viewing Print Preview in the RFx. The rates shall be quoted considering the above. Also the tenderer will have to carry out the above work as per the per the standard method.
- **C.** The rates quoted should be firm and price variation will not be applicable. The offer quoted shall be valid for 120 days. The same is mentioned in the RFx and which is to be accepted by the bidder in the SRM system while participating in the Tender. Also, all the Terms and Conditions of the Tenders are to be accepted by the bidder through SRM System while participating in the Tender.
- **D.** The successful bidder shall have to pay the prescribed security deposit amounting to 10 % of the total value of the contract in the form of B.G./D.D. of any nationalized/Scheduled bank in the name Executive Engineer,400kv R.S. Division, Deepnagar,BSL-II,MSETCL, payable at Bhusawal Dn.office within 15 days of receipt of LOI. The successful bidder shall also execute a stamped agreement at Division level at his own cost in the Company's standard before starting of work.
- **E.** Tender which do not fulfill all or any of the above conditions or incomplete in any respect are liable to summarily rejection.
- **F.** The submission of the on line tender by bidder implies that he has read these instructions, the conditions of contract, etc. and he had made himself aware of the scope and specifications of the work to be done and conditions. Also rates including tools and plants etc. and other factors having bearing on the execution of the work will be provided by tenderer.
- **G.** The MSETCL will not pay any extra cost after acceptance of contract. The contractor must arrange for all the transport of materials at site and include all such cost in the rates quoted by him for finished work. The contractor will have to make his own arrangement for the transportation of the materials from the departmental store / site store to the actual work site at contractor expenses.

- **H.** A schedule of quantities is included in the tender document. It shall be definitely understood that the Company does not accept any responsibility for the correctness or completeness of this schedule and this schedule is liable to alterations, omissions, deductions or additions at the discretion of the Executive Engineer, 400kv R.S. Division, Deepnagar,BSL-II as set forth in the conditions of the contract or any part thereof shall not be sublet without the written permission of the Executive Engineer, 400kv R.S. Division, Deepnagar,BSL-II.
- **J.** The Maharashtra State Electricity Transmission Co. Ltd., or their officers who accept the tender, shall have the right of rejection all or any of the tender and will neither be bound to accept the lowest, nor to assign any reason whatever for the rejection of any tender or all tenders.
- **K.**MSETCL will not be responsible for non-submission of Bid due to any internet connectivity/server problem.
- L. Right to reject any or all E-Enquiry (Responses) without assigning any reasons is reserved by the undersigned.

3] EMD Return:-

Earnest money deposited will be refunded online through SRM System after approval from competent Authority. EMD will be credited to the bank account maintained by bidder in vendor Profile in SRM system. Bidders are requested to ensure that the bank details i.e. Account No., IFSC Code, Account Holder Name, Bank Name, Bank Address are correctly maintained in SRM System and update the same, if required.

- **A.** In case bank details are not maintained by the bidders in their SRM Vendor profile, EMD will not be refunded online and MSETCL will not be responsible for the delay.
- **B.** MSETCL will not be responsible for any financial implications in case incorrect bank details are maintained by the bidders as it is the sole liability of the bidder to maintain correct bank details to facilitate online refund of EMD.
- **C.** If S.S.I/N.S.I.C certificate do not indicate material/service required against present tender. If turnover or manufacturing capacity exceeds the limit indicated in S.S.I./N.S.I.C certificate specified by the concerned authority to avail the benefit of E.M.D exemption .
- **D.** No interest shall be allowed on the earnest money deposit in respect of unsuccessful tenderers. The earnest money will be returned as soon as the tender has been finalized and upon the tender returning to the Company the receipt thereof duly discharged in favor of the Company subject to availability of fund.
- **E.** EMD will be refunded on the Bank A/c, which is maintain in the Vendor profile on SRM portal.In case bank details are wrong, MSETCL will not be responsible for non-receipt of EMD.
- **F.** The micro and small enterprises (only manufacturing and service enterprises) as defined in MSMED Act,2006 exempted from paying EMD and tender fees. The Udyog Aadhar Memorandum and Udyog Aadhar Registration certificate submitted by said enterprises should indicate the same Material/Services as required the tender floated.
- G. The Bidder has to pay EMD and tender fees in following cases:-

If the Micro/Small Enterprises Registration Certificate does not indicate the relevant classification code covering material/Services as required against the tender floated.

- **H.** If the investment in plant and machinery or Equipment exceeds the there should limit indicated in the MSMED Act 2006 (at present the threshould prescribed limit being for Micro– upto Rs.25 lakhs: Small-Rs.25 lakhs to Rs.5 crs.as investment in plant and machinery and for Micro-upto Rs.10 lakhs:-Small-Rs.10 lakhs to Rs.2 crs as investment in Equipment
- **I.** In case of Works Contract, if the Micro and small enterprises submits that the enterprises shall supply all the materials of intended works contract, manufactured from its then it shall be eligible for exemption of payment of EMD & Tender Fees to MSETCL. However, an undertaking duly notarized from Micro and Small Enterprises to this effect is to be submitted along with bid.
- **J.** The works contractor except as stated above and traders are excluded from the benefits of EMD and Tender fees, hence shall be required to pay EMD or tender fees while participating for e-tender process at MSETCL.
- **K.** The registration certificate as submitted by micro and small enterprises should be valid on the date of submission of bid and the validity of the same should be certified by the chartered Accountant in practice.
- 4] "Bidders have to submit an undertaking in the attached Proforma ANNEXURE-G declaring that their Firm is not Debarred/Blacklisted by Government/Semi-Government/Other Power Utilities, anywhere. If it is revealed that the participating Bidder is Debarred/Blacklisted by any Government /Semi-Government/Other Power Utilities, anywhere, the Offer of such Bidder shall be liable for rejection at any stage of Tendering process.

Further, if it is revealed that the successful Bidder is Debarred/Blacklisted by any Government /Semi-Government/Other Power Utilities, anywhere, then Order of such Bidder shall be liable for termination at any stage of Order execution process and the concern Bidder shall be solely responsible for the consequences arising therefrom."

5] JV:- JV should be a legally registered document.

6] **DISQUALIFICATIONS** :

The tenderer may be disqualified in the following conditions:-

- A. Disclosing untrue and/ or false information, or withholding information or part of information.
- **B.** Record of poor performance such as unsatisfactory work or abandoning the work etc.
- **C.** Financial short comings, or failures in past contracts Insufficient experience, or employing insufficient number of employees, or no Employing qualified employees.
- **D.** Non payment or requisite EMD.
- **E.** All the schedule of price bid should be fully completed otherwise liable for disqualification
- **F.** Bidder are requested to quote the GST separately otherwise consider for disqualification.
- **G.** If any wrongly quoted taxes or price by the bidder will be decided by the tender authority may consider or may not be considered, which is applicable for all bidders.
- H. The EMD and Tender fees is to be paid online on the account of MSETCL.
- I. If S.S.I/N.S.I.C certificate do not indicate material/service reburied against present tender.

- **J.** If Turnover of manufacturing capacity exceed the limit indicated in S.S.I/N.S.I.C.certificate specified by the concern authority to avail the benefit of EMD exemption.
- **K.** If required EMD is not paid by the bidder the offer is liable for rejection.
- L. If bidder wants the exemption from EMD certificate should be enclosed, otherwise disqualified.
- **M.** If it is observe that the certified produced by the bidder is false or wrong then the bidder is liable for rejection or if order is awarded same will be cancelled at any stage.
- **N.** If the bidder quotes the rates more than $\pm 5\%$ of the estimated cost, bidder has to provide justification and undertaking to carry out the work.
