Technical bid (Qualifying Criteria): Tenderer should upload the following digitally scan copies of original documents / certificates online under technical bid.

1. Valid solvency certificate equivalent to an amount not less than **25 %** of the estimated cost of works from scheduled / nationalized bank for the current year.
2. Average annual financial turnover during the **last 3 years** ending 31st March of the previous financial year, should be at least 50% of the estimated cost i.e. **Rs. 1027776/-** In support of this, the bidder shall submit the annual audited report certified by the statutory auditor in case of company & by Chartered Accountant where accounts are not required to be audited under any law. **Submit Turnover certificate for last 03 years.**
3. Income Tax Returns of last 03 years latest& Pan Card copy.
4. Experience of having successfully completed similar works amounting to 60% of the estimated cost in maximum 3 orders during last 5 years ending last day of month previous to the one in which applications are invited.
5. Proof of Service Tax Registration for Cargo handling and goods transport.
6. The bidder should have valid Transport Contractor License.
7. The transporter should have own crane. Consent letter from other transporter shall not be submitted. Proof of crane Vehicle registration certificate in the name of transporter, taxation payment receipts, etc. of the vehicles which will be use for work under this contract shall be attached. Details of T&P required to execute the work.
8. Professional tax registration certificate
9. Proof of registration of firm under Bombay Shop and Establishment Act.
10. Valid insurance against workmen compensation act.
11. Joint venture will not be allowed.
