TERMS AND CONDITIONS:

- 1) The work should be carried out as per MIDC specification/norms and DC rules & instructions.
- 2) Payment will be made as per
 - a) The 40% payment will be release after Site Survey of existing building, creation of submission drawings as per MIDC guidelines and submission of online construction permission with MIDC Authority.
 - b) Next 40% payment will be released after submission of online proposals for Building Completion Certificate.
 - c) Next 20% payment will be released after on received of actual submission of Building Construction and Completion Certificate.
- 3) The work should be completed within (90) days from the date handing over the site, failing which the contractor shall be liable to pay as compensation an amount equal to one percent or such similar amount as the competent authority may decide of the W.O. cost for every day the work remain unfinished after due date of completion subject to the maximum 10% of the cost of the order.
- 4) The work which is of bad workmanship quality will not be measured and paid.
- 5) Required Correspondence Letters/ Documents will be provided by MSETCL.
- 6) Income Tax as per the prevailing income Tax rule and subsequent amendment thereof will be recovered at source of your bill on total value of work done for which the certificate will be issued if desired.

Executive Engineer (Civil) EHV CCCM Sub-Division II, Dist: Aurangabad the undersigned. Payment will be made within 60 days period from the date of receipts

- 8) The terms and conditions in the M.S.E.T. Co. Ltd. Booklet 'Tender and contract work' will stand applicable for this work.
- 9) You will have to deposit 2.5% of Work Order Amount as security deposit in cash or DD of any nationalized Bank within 10 days from the date of receipt or receipt of work order, failing which EMD paid will stand forfeited. Remaining Security Deposit (2.5% of work order amount) will be recovered from your bills.
- 10) The contractor's offer will be considered as inclusive of all taxes and charges and it will be the contractor's responsibility to pay the taxes to Government and same will not be reimbursed to the contractor.


