Sub: AMC on quarterly basis for weed control by grass cutting method including removal of grass, digging bushes, tree cutting with chemical treatment from license holder in metal and non-metal area at 220 KV Yavatmal S/stn under EHV O&M Division, Yavatmal.

Dear Sir,

Please quote your lowest rates for the work under subject as per given in SCHEDULE "A" and subject to the terms and conditions given below. The quotation may please be submitted in a sealed envelope superscripted as "**Quotation for AMC on quarterly basis for weed control by grass cutting method including removal of grass, digging bushes, tree cutting**", so as to reach this office on or before **01/07/2020 up to 12:00 Hrs.** Quotations will be opened on the same day @ 1500 Hrs at EHV O&M Division, Yavatmal if possible.

TERMS AND CONDITIONS

- 1) **RATES:** Should stand firm at least for three months, otherwise maximum percentage in the rates should be stated.
- 2) **TAXES:** Taxes which are applicable for the said work should be clearly mentioned in the bid/quotation.
- 3) **DOCUMENTS:** Following essential documents shall be submitted along with the quotation:
 - Valid Shop & Establishment Registration Copy
 - Valid electrical contractor license copy
 - Valid Pesticide license from the competent authority for the work under subject.
 - Copy of valid GST registration certificate
 - Copy of PAN card.
 - Experience certificate of performing similar type of work.
- 4) **WORK COMPLETION PERIOD:** The work is to be carried out urgently and should be carried out as per instructions given by the concerned S/stn In-charge to the contractor. The working period should be strictly adhered to. Urgent works shall be taken up immediately after the call.

5) **SCOPE OF WORK:**

- a) Removing of grass, buds, thorny bushes, small thorny trees from the switchyard along with disposal of grass at safe location as per the instructions of site in-charge.
- b) Four consecutive round in a year i.e. ultimately all the area of switchyard should be free from grass during work validity period.
- c) Applying chemical treatment in metal and non-metal area. Ultimately yard should be clean & free from growth of any type of grass, shrub & weed from s/stn fencing to trench area in switchyard. After applying chemical treatment, bidder should have remove grass, shrub etc within 15-20 days & dispose the grass at safe location.
- d) If vegetation growth is seen after chemical treatment, that area should be spread with chemical free of cost to maintain the switchyard clean and free of vegetation.
- e) Routine maintenance of switchyard should be done throughout the period of one-year till completion of contract in such a way that the switchyard should be maintain clean and free of vegetation
- f) **as per Schedule-A.**

- 6) **SUPERVISION:** The work should be carried out as per instructions given by concerned s/stn In-charges and to the entire satisfaction of the said In-charge or officer nominated by this office.
- 7) **PENALTY:** If you fail to execute the work within stipulated period mentioned, penalty @ of 1/2% per week maximum up to 05% shall be imposed on the cost of the work.
- 8) **SECURITY DEPOSIT:** The successful bidder will have to pay security deposit amounting to 05% of the total value of order by cash/BG/FDR. The same will be refunded without any interest after satisfactorily completion of work and finalization of bills.
- 9) **AGREEMENT:** An agreement with M.S.E.T.C.L., will have to execute on Stamp paper of Rupees 500/- as proof on your cost within 7 days after receipt of order by the successful bidder.
- 10) **MSETCL RULES:** In addition to above, the contract will be governed by General terms and conditions mentioned in MSETCL booklet of contract terms and conditions.
- 11) **DEDUCTIONS:** Income Tax, labour cess & GST TDS will be recovered as per rule from your bills.
- 12) **LOSS/DAMAGES:** For damages if caused to company's property during execution of work shall be at contractors account and will be recovered from your SD/Bills.
- 13) **CHECKS & INSPECTIONS:** The work should be checked by the officer In-charge and will be cross checked by the undersigned if necessary.
- 14) **GAURANTEE / WARRANTY:** **Guarantee/warrantee does not apply to this contract; however,** the defects if any developed/observed in the work should be attended at your own cost. 5% SD amount will be retained for the contract operating period which will be released only after expiry of the contract or after one year from the date of order whichever is later.
- 15) **BILLS:** After satisfactory completion of the work, quarterly bills in triplicate shall be submitted to concerned SDO/in-charge along with JMC and other necessary documents etc. The officer in-charge after recording and necessary certification of the bill in MB will submit to the office for payment.
- 16) **PAYMENTS:** Payment will be made by this office on completion of the work, against submission of bills at the earliest depending upon availability of funds.

- 17) **CANCELLATION OF ENQUIRY:** The undersigned reserves the right to cancel this enquiry at any stage without assigning any reasons.
- 18) **JURISDICTION:** All disputes or difficulties arising out of or in connection with the contract shall be subject to the exclusive jurisdiction of Yavatmal District.
