## **TERMS & CONDITIONS:**

- 1. Rate shall be quoted on firm quotation basis inclusive of mobilization charges, transportation charges if any and GST. Rate shall be valid for 120 days from the date of quotation.
- 2. The work shall be completed within 15 days from the date of handing over of site otherwise penalty @ 1/2% per week subject to max. 5% of the order amount will be levied at the discretion of the Competent Authority.
- 3. You will have to pay **Security Deposit of 10%** of the total work order amount from the date of acceptance of offer and the same will be refunded after one month of work completion subject to deduction, if any.
- 4. The required material is kept at Theur site store and shall be transport to work site by contractor on his own cost. No T & P & Labour will be provided by the Company.
- 5. Income tax will be recovered from your bill as per rule.
- 6. Valid Shop Act / Udyog Adhar Certificate, GST registration, PAN card, Valid Electrical License should be enclosed with quotation.
- 7. The contractor should have the experience of similar work in the EHV transmission line/ substation work. The experience certificate along with work order copy should be submitted with quotation.
- 8. The payment will be made at the office Executive Engineer EHV Project Division- I,Pune .The tax invoice, advance stamp receipt, along with the certificate from the Engineer in- charge for having completed the work satisfactorily must be submitted to this office for processing the payment at division office level.
- 9. The contractor shall make every effort to minimize the breakages, losses and wastages of the line materials during erection of the material supplied by the owner.
- 10. The contractors shall employ and provide onsite only such employees who are skilled and experienced for execution and supervision of works. The contractor shall provide housing accommodation to his employees. He shall also be responsible for any injury / accident to his employees, payment of compensations etc. as may required to be paid eventually, shall be borne by the contractor himself. The contractor should

ensure that his staff uses the requisite safety equipment. The employees should be duly insured against any such eventuality.

- 11. If any damages occur to the MSETCL property during execution of work you will have to make them good at your own cost.
- 12. If any accident occurs to your labourers skilled or unskilled persons at work compensation if any is to be paid by you only. **Idle labour charges will not be paid**. All safety Precaution should be taken during execution of work.
- 13.In case you fail to complete the work entrusted to you partly or fully, the undersigned reserves the right to get the balance work carried out through other agency and difference in cost will be recovered from your bill / S.D. If the balance remained to be recovered the same shall be recovered from your bill.
- 14. The Contractor should always keep & maintain First Aid Box for this work as safely measure.
- 15. Notwithstanding anything stated herein, the MSETCL's General Terms and Conditions of Contract shall be applicable to the contract, as far as they are applicable to this contract also.
- 16. The undersigned reserves the right of cancel the order, after giving due notice to the contractor, in the event of the breach of contract in any respect or under delay in lexecution of work / starting of the work.
- 17. The undersigned reserves the right to place order either partly or fully or to reject any or all the quotations without assigning any reasons whatsoever.
- 18. If any dispute or court case arises; then jurisdiction of court shall be Pune Court only.
