Sealed & super scribed quotations are invited on firm quotation basis for the works indicated in schedule 'A' so as to reach this office on or before 10/07/2020 up to 15.00 hrs. On following

#### **Terms & Conditions:**

The offer should be submitted in sealed envelope containing documents as well as price bid super scribing the subject. This should contain following documents certificates as a proof of qualifying pre- requisites, broachers, self-attested copy/certificates etc.

- 1. PAN Card
- 2. Electrical contractor License
- 3. Valid Shop act & establishment registration or NOC of Grampanchayat
- 4. Proof regarding GSTIN registration.
- 5. Work experience certificate issued by the competent authority not below the rank of Executive Engineer of similar work & copy of work order for the same.

#### **TERMS & CONDITIONS:**

- 1. **WORK COMPLETION PERIOD:** The work should be carried out as per instruction of EE or his representative **within 60 days** from the date of handing over of Lamps/Lights'.
- 2. **PENALTY**:- If you fail to execute the work within stipulated time as mentioned above, you will be liable to pay penalty at the rate of ½% per delayed day, subject to a maximum limit of 10% of the total value of the order.
- 3. **<u>OUALITY</u>**: The work should be carried out as per satisfaction of SSI & as per schedule, otherwise same will be rejected and you will have to replace / repairs at your own risk and cost only.
- 4. **GUARANTEE**: The work as a whole shall be guaranteed for trouble free service for period of 12 months from the date of commissioning of CT after repairs.
- 5. **GENERAL**: You should make yourself fully aware of M.S.E.T.Co.Ltd.'s general condition of contract for supply of material and execution of work.
- 6. <u>AGREEMENT</u>;- You will have to execute the agreement bond on stamp paper of Rs.500/-with Executive Engineer, RS O & M Division 400KV CHAKAN, The cost of stamp paper will be borne by you.
- 7. **PAYMENT**: Payment will be made to you against after confirmation of work carried out from concerned field engineer in-charge. The M.B. recording & service entry of the bills will be done by respective field engineer in-charge. Scrutinizing & auditing will be done at EE 400KV Division Office and payment will be effected accordingly subject to availability of funds.

- 8. Security Deposit: You have to pay security deposit within 10 days from the date of receipt of the work order, amounting to 5% of the value of the contract/order in the form of Cash/FDR/D.D./BG of any Nationalized/ scheduled Bank in the name of EE RS O &M Division 400KV CHAKAN, payable at Chakan valid for one year.
- 9. In case of difference of opinion about any interpretation of any clause of term and condition arising during the period of the contract the decision of the undersigned will be final and binding on you.
- 10. **TERMINATION OF CONTRACT**:- The undersigned reserves the right to accept or reject the enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 3 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor. Undue delay in completion of contract work is also liable to getting the work done through other agencies at the risk and cost of the contractor.
- 11. In case the work is not executed partly or fully the balance work will be got carried out from some other agency even at higher rate and difference in cost will be recovered from your pending bill with the Company or Security Deposit will be forfeited in addition to above.
- 12. Work Contract Tax: As per prevailing rates will be deducted from your bill, if applicable.
