- 3] The supplier has to furnish GST, PAN No. in the offer.
- 4] **Work Period :** The software shall be supplied & installed within 15 days from the date of receipt of the order.
- 5] **Taxes:** The rates quoted shall be inclusive of GST & all other duties, which are payable by the contractor as per statutory regulations.
- 6] **Rates :** Rates should be firm and for the said destination inclusive of all taxes.

- 7] Income Tax shall be deducted from the bills at prevailing rates as per Income Tax Act, 1961 if applicable.
