- 1. The rates [percentage] should be quoted on Firm Quotation basis including cost of materials, Labour charges & T & P etc. required for execution of the work. The Estimated Cost Rs. 1,94,688.00 { Rs One Lakh, Ninety Four thousand , Six Hundred Eighty Eight Only }
- 2. The quantities enumerated in here attached Schedule "B" are approximate, however the payment will be made against actual executed quantities on site.
- 3. The rates / Percentage should be quoted in figures as well as in words.
- 4. While submitting the quotation the contractor should pay E.M.D. Rs. 2,000.00 in this office & the M. R. No. thereof should be super-scribed on the Envelope.
- 5. The work should be completed within 12 Months from the date of handing over the work site to commence the work, Failure of which a penalty at 1/2% or such smaller amount as C.A. may decide per week on unfinished value of work subject to the maximum 05 % of the ordered value will be imposed.
- 6. The work should be strictly carried out as per standard specifications and up to the entire satisfaction of the Engineer-in-charge.
- 7. Cement of approved make of Manikgarh / ACC / Orient /Rajshree as per IS i.e. 53-Grade OPC or equivalent Approved make will be procured and used.
- 8 No materials will be supplied by the MSETCL for this work.
- 9. Payment will be made through **R.A. bill basis Per month** at the discretion of undersigned.

- 10. The contractor will have to pay security deposit to the MSETCL equal to 5% of the ordered value.
