- 4) **Payment:** 100% payment will be effected within reasonable time after satisfactory work completion from our EHV O&M Division Ratnagiri.
- 5) **Security Deposit:** The successful bidder will have to pay an amount equivalent to 5% of the contract value towards security deposit after receipt of LOI in form of cash/DD/FDR/BG of any Nationalized/ Schedule Bank in the name of Superintending Engineer EHV O&M Circle Kolhapur, payable at Kolhapur valid for equal to or more than one year. S.D. will be refunded only after successful completion of work.
