- 2) <u>Validity of offer</u>: The offer should be valid for our acceptance for period of 120 days from the last date of submission of offer/ quotation.
- 3) Quantity of supply: The material should be supply as per specification mentioned in schedule 'A'.
- 4) <u>Security Deposit</u>: The contractor should pay security deposit at the rate of 10% of the value of the order after receipt of LOI in form of cash/DD/FDR/BG of any Nationalized/ Schedule Bank in the name of Superintending Engineer EHV O&M Circle Kolhapur, payable at Kolhapur valid for equal to or more than one year. The S.D. will be refunded after satisfactory completion of the guarantee period.
- 5) <u>Agreement Bond</u>: The contractor will have to execute an Indemnity Bond on stamp paper of **Rs.500**/- at his own cost if order is placed.
- 6) <u>Guarantee Certificate</u>: You should submit the guarantee of supplied material for a period of one year from the date of receipt of material.
- 7) <u>Delivery period</u>: The material should be deliver within 30 days from the date of receipt of work order at EHV O&M Dn., Ratnagiri.
