
1. The Rate shall be quoted on firm quotation basis.

3. The price quoted by you in your quotation for supply of the material shall be on firm quotation basis.
4. Your quotation should reach this office **on or before 26.08.2020 up to 11:00 hrs** and the same will be opened on the same day, if possible.
5. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
6. Documents required:- The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
  - A. Copy of Valid Shop act
  - B. Copy of Valid Proof of registration under GST.
  - C. Copy of Pan card of the agency /owner of the agency
  - D. Certificate of Authorized Dealership / Service provider / Distributor of Air Conditioners i.e. of M/s. Blue Star or Ms/. Lloyed or M/s. Daikin or M/s. Carrier
7. **Quantity :-** Quantity shown in "Schedule" may vary as per requirement. However the order value will be limited to Rs. 1,97,798/- only (including all taxes/duties).


