- 2) The quotation must be written with ink or typewritten. Any as catching or over writing must be initialed.
- 3) **RATES:** The rates shall be inclusive of all taxes and duties, charges etc. for the works at MSETCL's site.
- 4) **PERIOD OF WORK COMPLETION:** The work shall be completed within 07 days from the date of handing over of particular site being one part of the order by the authority concerned Engineer incharge / Dy. Executive Engineer. However in view of Monsoon season, relaxation may be given depending upon the weather condition. The decision of the concerned Engineer incharge will be final in this regard.
- 5) **PENALTY:** If the agency fails to execute the work within stipulated period mentioned above then, the penalty @ of ½ % per week maximum 10 % shall be levied on contract value.
