- b. This office reserves all the rights to reject any or all bids without assigning any reasons thereof.
- c. The offer shall be valid up to 120 days from the date of opening of the quotation/bid

Place of work – 400KV RS & 220KV S/S Sub-station under 400KV R.S. O&M DIVISION, DHULE. <u>"The estimated rates given by this office are inclusive of taxes (i.e.18% GST + 1% Labour cess on total Amount incl. of GST). However, the bidder should quote rates exclusive of GST only. The GST should be quoted separately."</u>

- 3. The order value will be limited up to Rs-1,45,222.03/- only including all taxes and the contract period will be one year or till the exhaustion of Order Value.
- 4. The contractor has to pay **5% of the Order value as a Security Deposit**, in FDR/DD/BG before after issuing of LOA. Same will be refunded to the contractor after successful completion of contract period.
- 5. The contractor has to execute the **agreement** as per the provision of 'Mumbai Mudrank Adhiniyam 1958, Clause No. 34' with Rs.100=00 stamp duty before starting of the work.
- 6. Liquidated Damages / Loss due to theft: Any damage or loss to M. S. E T. Co. Ltd.'s property due to bidder's employee's/workers negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.
- 7. Work should be carried out as per the directives of Executive Engineer, 400KV R.S. Division Dhule or its representatives i.e. Incharge of 400KV RS/220KV Sub-stations Dhule.
- 8. **Technical Skilled Persons:** The contractors shall employ and provide onsite only such employees who are skilled and experienced for execution and supervision of works. The contractor shall provide housing accommodation to his employees. The company will not provide accommodation to your technicians / supervisors, labours at various places He shall also be responsible for any injury / accident to his employees, payment of compensations etc. as may require to be paid eventually, shall be borne by the contractor himself. **The contractor should ensure that his staff uses the requisite safety equipment**.
- 9. The employees should be duly insured against any such eventuality. Your Labour should be covered under group insurance against electrical / mechanical hazard during the work of contract. In case of accident if any injury fatal or non-fatal is caused to the Labour, MSETCL will not be responsible for any monitory claims arising out of accident. It will be the sole responsibility of agency to arrange for suitable insurance to cover such monitory claims.

- 10. If any type fatal/non-fatal accident occurs, whole responsibility shall be of Bidder/Contractor. MSETCL shall not be responsible for that. Contractor will have to provide safety equipment's to his employees.
- 11. **Failure to execute the work:** If the work is not executed in the stipulated period the MSETCL shall be at liberty without further notice or reminder to the contractor, to get the same work done from any other agency at risk & cost of contractor. If you fail to carry out the work in full or in part, the work will be got carried out from other party even at higher rates and the difference in rate will be recovered from you. **In that case MSETCL will forfeit the SD submitted by you.**
- 12. **Hindrance of work**: If the work has to be suspended due to any reason, shut down etc., MSETCL shall not pay any compensation / damage to the contractor towards item like idle Labour, idle machinery, vehicles etc. However, in such case the contractor will be paid for the actual work executed by him under the supervision & measured by concerned Engineer.
- 13. **Tools & Plants:** -All tools & machinery required will have to be arranged by you at your cost. If the tools & plants are provided by MSETCL on rent basis, the standard rent as per MSETCL rules shall be recovered from your bills. The material used to be strictly as per standard specification. You will be responsible for quality of work & workmanship. On completion of the work the agency shall clear away & remove all the surplus material from the site.
- 14. **Sub Letting of contract:** The contract or any part thereof shall not be assigned, transferred, or sub let without the prior written permission of the undersigned. Even if such permission is granted, it shall be the responsibility of the principle contractor to whom the work order was originally issued, to execute the works as per the terms of the contract.
- **15. Penalty:** If the supply as well as work is not completed within stipulated period the penalty @ ½% per week subject to maximum 10% of the order value of work, will be levied. Loss to MSETCL property or equivalent etc. due to your negligence will be penalized & will be recovered from the bill.
