Terms & Conditions:

The offer should be submitted in sealed envelope containing documents as well as price bid super scribing the subject. This should contain following documents certificates as a proof of qualifying pre- requisites, broachers, self-attested copy/certificates etc.

- 1) SCOPE OF WORK:- This RE tender is for Supply & installation of 1.5 Ton five Star inverter A.C units of TOSHIBA/HITACHI/IFB make & ISEER rating of **4.69 to 5.6** to be required at 400KV Chakan s/s. as per Schedule 'A'.
- 2) **PERIOD OF CONTRACT**: The total period of contract is 2 months (60 DAYS) from the order date by this office.
- 3) **VALIDITY:** All bids shall be open for acceptance by the Company for a period of 120 days from the date of opening of the bid and the bidder shall be bound to carry out the work on such acceptance within this validity period. All bids submitted against this enquiry shall be deemed to comply with the conditions unless otherwise agreed by the Company.
- 4) Quotation Submission: The bidder must quote his rates specified in the Schedule in figures as well as in words. Any variation/revision in the rates will not be allowed on any grounds such as mistake, misunderstanding etc; after the quotation has been submitted. The bidder rate must include loading, unloading, charges etc.; as per Schedule- A.
- 5) **SECURITY DEPOSIT**: Every bidder whose bid is accepted either in whole or in part must deposit money within seven working days from the date of receipt of intimation by way of Security for the due and proper fulfillment of his contract by D.D. or by Cash. Security Deposit is payable at 5% of the amount of the order.

 In the event of the contractor failing to deposit such security within the stipulated period the company shall have full discretion to cancel the acceptance communicated the said tender. Subject to deductions if any as per the terms of the contract, the security deposit will be returned in the normal course within 3 months after the expiry of the completion of the work. No interest will be allowed on this deposit.
- 6) **EXECUTION OF WORK:** In the event of tender being accepted in the whole, the successful tenderer, hereafter referred to as the contractor shall execute order immediately as per Schedule 'A' enclosed within 30 TO 45 Days from the date receipt of order or intimation from this Division.
- 7) SUBMISSION OF BILLS: The bills for the work as per Schedule 'A' along with completion of work report duly signed by sub-station in-charge should be submitted in triplicate on the name of Executive Engineer, M. S. E. T. C. L. 400kV Receiving Station (O&M) Division, Chakan to concerned Engineer-in-charge. The M.B. recording of the bills will be done by Engineer-in-charge. After receipt of bills from the concerned Engineer-in-charge, auditing will be done at Division Office and payment will be effected accordingly subject to availability of funds.
- **8) PENALTY FOR LATE EXECUTION OF THE WORK:** If the work is not completed as per the Schedule in specified time, the contractor shall be liable to pay penalty at 1% per day subject to a maximum of 10% of the value of the order.
- 9) FAILURE IN EXECUTION OF WORK:- For failure of execute the work as per Schedule against the order in full, within the stipulated period, the company shall be at liberty without further notice or reminder to the contractor, to get the same work done on account of and at the risk of the contractor and to prefer a claim for a difference in price and for all expenses whatsoever incurred in getting the said work and same shall be

recovered from any money due to the contractor from bills or deposits on any account with any MSETCL's offices. Such expenses will also include 15% supervision charges.

- **10**) **GENERAL**: You should make yourself fully aware of M.S.E.T.Co.Ltd.'s general condition of contract for supply of material and execution of work.
- 11) <u>PAYMENT</u>: Payment will be made to you against after confirmation of work carried out from field in-charge Engineer within reasonable period subject to availability of funds by this office. The auditing will be done at Division office after receipt of bills through concerned section in charge duly recorded in MB.
- 12) In case of difference of opinion about any interpretation of any clause of term and condition arising during the period of the contract the decision of the undersigned will be final and binding on you.
- **13**) **TERMINATION OF CONTRACT**:- The undersigned reserves the right to accept or reject the enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.
- **14) INCOME TAX & WORK CONTRACT TAX: -**Income Tax & Work Contract Tax (if applicable) will be deducted from the contractor's bill.
- **15) AGREEMENT;** The contractor will have to execute an Indemnity Bond on stamp Paper of ₹. 500/- at his own cost before commencement of work.
- **16**) All general/Technical/Commercial terms and conditions of the contract of the Company are applicable to this contract.
- 17) The right to reject all or any of the quotation by assigning reason, whatsoever for the rejection of any quotation or all the quotations or to place an order for full quantity or part thereof or to finalize the order on time preferred basis or to split the order quantity wise is reserved with the undersigned
