 - (iii) GST/ GSTIN Registration Certificate.
 - (iv) Experience of having successfully completed similar types of works.
 - (v) Payment of EMD Rs. 1000.00 to be made by bidder off-line only upto 14.00hrs of 23/10/2020 in the office of EE(C), Dn., Nashik. EMD details Amount and M.R. No. should be super-scribed on the Envelope
 - (b) **Documents in 2nd Envelop:(Price Bid)**
 - (i) Price bid only where in the rates/percentage should be quoted in figures as well as in words.

NOTE:- Envelop No.2 (Price Bid) will be opened after qualifying in (Technical Bid) Envelop No.1

- 2) The quantities enumerated in here attached Schedule B are approximate, however the payment will be made against actual executed quantities on site.
- 3) The work should be completed within **One year** from the date of handing over the site to commence the work, failing of which a penalty at ½% per week subject to the maximum 10% of the ordered value will be imposed.
- 4) The work should be strictly carried out as per standard specifications & up to the entire satisfaction of the Engineer-in-charge.

- 5) No materials will be supplied by the MSETCL for this work except materials as shown in Schedule B.
- 6) Payment will be made through First & Final bill/ R.A. bill basis at the discretion of undersigned.
- 7) The contractor will have to pay security deposit to this office equal to 5% of the ordered value.
- 8) In case any accident occurred to the Contractor's labour/workmen during execution of work, the contractor will be fully responsible for all claims & compensation. No charge in any case will be borne by the MSETCL
