SPECIAL CONDITIONS

1) The tenders should be submitted into two separate Bids.

Technical Bid

The Technical bid should contain following documents certificate / as a proof of qualifying pre-requisites.

Requisites:

- 1) Income Tax return filed for the last three financial assessment year & PAN card.
- 2) Valid Electrical Contract License.
- 3) Insurance of Labour.
- 4) Solvency certificate from Nationalized/ Schedule Bank to the extent of 25 % of the estimate cost of the works.
- 5) Bombay Shop & Establishment Act certificate.
- 6) Registration under GST as well as for other various taxes in force.
- 7) EPF Registration Certificate.
- 8) Agency should have to submit proof of NABL Authorized Mobile VAN.
- 9) Details of orders executed or in hand with amount.

10) Minimum Qualifying requirement of the bidder:

- 1) The bidder must have experience of having successfully completed similar type of work during last five years (from scheduled date of submission of tender) having
 - a) One similar completed works not less than the amount equal to 80% of the estimated cost OR
 - b) Two similar completed works not less than the amount equal to 50% of the estimated cost OR
 - c) Three similar completed works not less than the amount equal to 40% of the estimated cost OR
 - d) For all above works, satisfactory work completion certificate is mandatory.

The bidder must have the experience certificate not below the rank of Executive Engineer in any transmission utility OR Govt. OR Semi Govt. utility.

11) Turnover:

The bidder should have minimum turnover of 60% of the tender estimated cost during any one of the preceding three financial years (i.e. financial year 01.04.2016 to 31.03.2017, 01.04.2017 to 31.03.2018 & 01.04.2018 to 31.03.2019).

The bidder should furnish the above details duly Certified by the Chartered Accountant along with his bid.

Commercial Bid

Bidder should submit the rates in the SRM e-tender for each items in 'Conditions' tab which is under 'Items' tab as per the guidelines attached for participating in the RFX. "The price Bid shall not be attached in the document format i.e. by preparing the price bid and by uploading/ attaching the scan copy of the price Bid. The same will be not accepted".

- 1) The commercial bid will be opened online in respect of those bidders who are qualified in QR of technical bid.
- 2) The Competent Authority reserves the right to relax any of the above conditions without assigning any reason thereof.
- 3) The comparison of rates quoted by various bidders will be on the basis of overall cost of the package.
- 4) Any variations/ deviations from the specification in respect of the description of above work or the conditions of tender must be specifically brought out in the covering letter. If this is not done, it shall be deemed that the tender is in accordance with the specifications and shall be binding on the tenderer.
- 5) Earnest money deposit and Tender fee should be paid only by online.
- 6) The tender value is Ltd. up to **Rs.7.5 Lakhs** (inclusive of all taxes).
- 7) Before quoting the rate you should be ensured site location.
- 8) The tender shall be valid for acceptance for a period of 120 days from the date of opening of tenders and during this period no tenderer should be allowed to withdraw this tender. Any such withdrawal during this period will be liable for forfeiture of EMD.
- 9) The contractor will have to execute an Indemnity Bond on stamp paper of **Rs.500/-** at his own cost if order is placed.
- 10) The provision made in various acts in force such as Workmen Compensation act and Contract Labour act 1970 are obligatory on the contractor while execution of work.
- 11) The contractor shall make his own arrangement for skilled labours, tools & tackles, crane and vehicle etc., nothing will be provided by the Company.
- 12) For any loss to the person or Company's property the contractor will be responsible and should pay for the same.
- 13) In case of dispute, if any, the legal jurisdiction of the Court shall be Ratnagiri only.
- 14) All the Company's general terms and condition of contract are applicable to this contract.
- 15) The company does not bind itself to accept the lowest or any tender neither will any reason be assigned for rejection of any tender. It is also not binding on the company to disclose any analysis report of tender.
- 16) The Company reserves the right to reject tender which does not confirm to any of the condition.
- 17) The tenderer should pay the security deposit of amount in form of cash/ DD/ FDR/ BG equal to 5% of order value within 7 days of receipt of LOI.
- 18) The technical Documents should be uploaded in Technical Bid & rates should be filled up in RFX information. In case both Technical & Commercial Bid are uploaded in one file wrongly, the offer will be rejected.
- 19) MSETCL will not be responsible for non-submission of Bid due to any internet connectivity/ server problem.

- 6) **Signing of contract:** Within 7 days from the date of receipt of work order, the contractor shall enter into an agreement with the MSETCL in the prescribed format. Until the agreement is executed, the MSETCL will not be liable to pay, nor the contractor shall be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by contractor.
- 7) **Execution of work:** Immediate after receipt of work order, the contractor shall take prompt action in planning the work in consultation with the concerned Sub-Division In-charge. He should also take steps for timely procurement of necessary material and tools and plant. The work should be carried out to the full satisfaction of the concerned Sub-Division In-charge. The provision made in various acts such as workman compensation act, contract labour act 1970 are obligatory while execution of work. Outages/ shutdowns required will be arranged by MSETCL. Contractor shall take necessary e-passes for movement of manpower, T&P & mobile van at site for execution of work from respective authority at own cost.
- 8) **Quality:** Work should be carried out as per specification in enclosed Schedule 'A' & details are as follows:
 - a) The works involve to testing the top & bottom oil samples.
 - b) In case of test results of any oil sample is found beyond normal specified limit the frequency of oil sample testing should be increased for condition monitoring of transformer.
 - c) The entire test results should be invariably submitted to Executive Engineer of the concern Division through concern substation In-charge within 48Hrs after receipt of sample. The soft copy of entire test result should be submitted within 24 Hrs on email ID – ee3220@mahatransco.in.
 - d) In case of any emergency such as failure of transformer, tripping of power transformer for which MSETCL desires for oil testing. In such event the required oil sample of transformer oil for testing purpose to be collected by you after call from MSETCL & test report should be submitted within two days, failure to which work will be completed from other agency & difference in cost will be recovered from your existing bill. In otherwise case sampling shall be done as per requirement & call from MSETCL (by e-mail or fax as & when required).
 - e) The required oil sample of transformer oil for testing purpose will be collected by you in presence of S/s In-Charge.
- 9) **Operating Officer:** The concern Executive Engineer is appointed as operating officer for this contract /work. You will have to carry out the works against schedule 'A' under EHV O&M Division Ratnagiri.
- 10) **Working period:** Annual testing of T/F oil should be done as per schedule given by respective Division within 15 days from the date of intimation from respective Division. In other cases, it should be carried out within 2 days from the date of intimation of S/s In-charge.
- 11) **Safety:** The contractor should provide all safety equipment required for the work to his workers. If any accident occurs due to non-supply of these equipments or careless handling of equipment the same shall be in the contractor risk and cost. The contractor must maintain first aid box in safe custody. Also, contractor should provide mask, sanitizer & other necessary safety equipments/ tools to deployed worker & take precautionary measures as per time to time guidelines issued by Govt. of India/ Health Ministry or Respective Collector Officer.
- 12) **Workman's Insurance:** The contractor shall obtain the Insurance Policy as Contractors All Risk Insurance (CAR) or Transit Cum Erection (TCE) Insurance or Erection All Risk (EAR) insurance for all the workman engaged by him for this works at MSETCL site. The policy should be drawn from insurance company entrusted by Directors of Insurance, Government of Maharashtra i.e. M/s United India Insurance Co. Ltd. on co-insurance cum servicing basis in the ratio of 40:60 (i.e. the Government Insurance Fund @40% and United India Insurance Company @60% which will be valid for 2 years.

- 24) **Jurisdiction**: All disputes, differences related to the tender/ contract shall be subject to the exclusive jurisdiction of Ratnagiri Court.
- 25) **Risk & Cost**: In case you fail to complete the work fully or partly, the balance work will be completed from other agency and difference in cost will be recovered from your bill and security deposit in this case will be forfeited to Company.
- 26) **Rework**: Any work i.e. to be carried or already executed work found defective due to faulty workmanship or improper execution shall be done good by the contractor free of cost, failing to which the work shall be got done by other agency and the cost shall be recovered from the contractor.
- 27) **Tools & Plants**: All the necessary Tools and machinery required for execution of the work shall be arranged by the contractor at his own cost. The company shall not be responsible for any damages/ theft to the contractor tools, plants, machinery etc. during execution of work / contract period. The contractor should arrange at his own cost for octroi charges or any other such type of local charges for his material T & P etc. The tool, plants and machinery brought at the site by the contractor shall effectively be used and shall not be removed from the site without approval of S/s In-Charge.
- 28) **Security Deposit**: The Agency should pay the security deposit within 7 days from the date of receipt of LOI of amounting to 5% of order value in form of cash/ DD/FDR/ Bank Guarantee of any Nationalized/ scheduled Bank in the name of Superintending Engineer EHV O&M Circle Kolhapur, payable at Kolhapur valid for equal to or more than one year. The security deposit will be refunded only after completion of guarantee period.
- 29) **Acceptance of Tenders**: The Company does not bind itself to accept the lowest or any tender neither will any reasons be assigned for rejection of any tender. It is also not binding on the company to disclose any analysis report of tender.
- 30) **Discarded Tender condition**: The Company reserves to itself the right to reject tender which does not confirm to any of the conditions. The tenderer whose tender is accepted must deposit money within 7 days from the date of receipt of intimation by way of security for the due and proper fulfillment of his contract by DD.
Security deposit is payable at 5% of the amount of order subject to the deductions if any as per the terms of contracts the security deposit will be returned in the normal course within 3 months after the expiry of the completion of guarantee period. No interest will be allowed on this deposit.
- 31) **Conditions of Tender and contract**: The tender and order / contract placed against this specification shall be governed by the Company's general condition of contract and the tender is deemed to be fully aware of these conditions and ignorance thereof shall not exempt him from his liability to abide by these conditions. The enclosed schedules, tender notice, tender form and instructions to the tenders also form a part of these specifications.
- 32) **Termination of Contract**: The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the event of the breach of contract in any respect. Undue delay in completion of contract work is also liable to result in the MSETCL getting the work done through other suitable agencies at your risk & financial cost.
