

6. No extra charge will be paid for vehicle driver, oil & other taxes & duties etc. only Toll tax is paid by MSETCL.
7. The fuel (Diesel) charges to be borne by MSETCL with the condition that the vehicle should give minimum 14 km/Ltr with AC and without AC 16 km/Ltr and manufacture of vehicle provided should not be prior to year 2019 at the time of enquiry floated.
8. The responsibility of comprehensive insurance, PUC, Taxi permit & RTO formalities will be with vehicle provider.


