(c) Bank Guarantee from a nationalized /scheduled Bank. The SSI units will have to pay security deposit as per statutory provisions. The security deposit will be refunded after satisfactory completion of the guarantee / warrantee period.
- 2) Guarantee Period: The material should be warranted by company for **Three year** from the date of installation against any manufacturing defects & will be replaced in case of defect arises in the warrantee period, should be replaced free of cost.
- 3) Delivery Period: The work should be supplied within 15 days from the date of issue of supply order to this office.
