
1. The Rate shall be quoted on firm quotation basis.

3. Your quotation should reach this office **on or before 17.12.2020 up to 17:00 hrs**. The quotations will be opened on the same day, if possible.
4. Quotation received after due date will not be considered. This office will not be responsible for any postal delay.
5. Documents required: - The rate offer must be accompanied with the following documents otherwise the offer will be liable for rejection.
  - a. Vehicle Registration Certificate
  - b. Vehicle Tourist/Taxi Permit
  - c. Driver with Valid Driving license
  - d. Valid Vehicle Insurance
  - e. Valid PUC certificate
  - f. Vehicle Fitness Certificate
  - g. Vehicle Model should not be more than 5 year old
  - h. Valid PAN No. & GST registration certificate
  - i. Valid shop act registration certificate

6. No extra charge will be paid for vehicle driver, oil & other taxes & duties etc. Only Toll tax will be paid by MSETCL.
7. The fuel (Diesel) charges to be borne by MSETCL with the condition that the vehicle should give minimum average of 12Km/Ltr.
8. The responsibility of comprehensive insurance, PUC, Taxi permit & RTO formalities will be with vehicle provider.
