- 2) Tender Fee: You should have to pay tender fee of Rs. 100 + GST@ 5% i.e. Rs. 105/- in SRM
- EMD: You should have to pay EMD of Rs. 5000/- in SRM only which will be refunded after finalization of work order & payment of security deposit
- 4) License:- You will have to submit the License copy for the use of the walky Talky set in the name of Executive Engineer 400kV R.S. Division Talandge.
- <u>Transportation & Transit Insurance :-</u> The necessary transport & Transport insurance is in your own scope.
- 6) TAXES & duties: (TDS of GST) & labour Cess as per rule will be deducted from your bill at source as per prevailing rates. Please quote your GST No. on bills. Also taxes will be applicable as per the rules.
- 7) You will have to execute the agreement bond on 500/-rupees stamp paper. The cost of stamp paper at your account.
