- 2) The quotation must be written with ink or typewritten. Any as catching or over writing must be initialed.
- 3) **RATES:** The rates shall be inclusive of all taxes and duties, charges etc. for the works at MSETCL's site.
- 4) **PERIOD OF WORK COMPLETION:** The work shall be completed within 07 days from the date of handing over of site by the authority concerned S/Stn incharge. The decision of the concerned S/Stn incharge will be final in this regard.
- 5) **QUALITY OF MATERIAL & WORK:** The material should be supplied strictly confirm to our specification & type otherwise same will be rejected & you will have to replace at your own risk & cost only. You will be responsible for quality of work & workmanship. Joint minutes of meeting should be made with Engineer In-charge after satisfactory completion of work
- 6) **PENALTY:** If the agency fails to execute the work within stipulated period mentioned above then, the penalty @ of ½ % per week maximum 10 % shall be levied on contract value.
- 7) **T & P/ LABOUR:** No T & P and labour will be provided by the MSETCL.
