The security deposit will be refunded after satisfactory execution of the order.
- 2) Guarantee Period: As per manufacturing standards. If any mishap/damage occurs in guarantee period, the same will have to be made healthy by you at your own cost & risk.
- 3) Delivery Period: The work should be supplied within 30 days from the date of issue of supply order to this office.
- 4) Penalty: If the material not supplied within stipulated period, penalty at 1/2% per week-subject to maximum of 10% of the Order value will be levied.
