TERMS & CONDITIONS :

- DUE DATE:-** The quotation completes in all respect, duly sealed & super scribed should be submitted to this office on or before **Dtd.29.12.2020 upto 18:00 Hrs** Positively.
- E-QUOTATION FEES:-** Agency should have to pay Rs.105/- (Rs.100+5% GST) against E-Enquiry Quotation Fees by cash to EHV O&M Circle Office Karad & copy of the money receipt should attached with the quotation this office.
- DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS :-** Please submit the following documents along with offer :
 - Copy of the Money Receipt against submission of e-enquiry fees.
 - Valid Electrical contractor license.
 - Income Tax Return for Last 03 Financial years.
 - Registration under PAN & GST.
 - Registration under Bombay Shop & Establishment Act /NOC from Local Grampanchayat.
 - Performance cum Experienced Certificate for above subjected work during last 05 years.
- ESTIMATED COST:-** The estimated cost is limited upto Rs.02,46,309/- inclusive of all.
- QUOTED RATES:-** The quoted rates should include the cost of all taxes. The taxes will be clearly mentioned, & if the taxes are not clearly mention, then it will be presume that the rates are inclusive of all taxes.

22. **OUTAGES :-** The necessary outages if required for above subjected work will be arrange by Ex. Engineer or concerned Addl.Ex.Engineer 400 KV LMSD-I &II.
23. **Payment :-** 100% payment against the bills for the work actually carried out will be given to you after deducting necessary taxes & duties as per Govt. rule either by cheque or NEFT/RTGS.
24. **PENALTY: -** If the supplied is not completed within the stipulated time period the penalty will be charges as per prevailing rate i.e. 1% per of the order value per week of delay maximum upto 10% of the total order value.
