- 2. Your sealed quotation should be submitted to division office on or before dt: **08.01.2021** upto **17:00 Hrs**.
- 3. Following documents should be submitted alongwith quotation:-
- 1. Proof regarding registration under shop & establishment Act 1948
- 2. GST registration copy
- 3.PAN card copy should be enclosed with quotation.
- 4. Experience certificate of EHV Line work (foundation, erection etc.)
- 4. **Site visit:** Agency is requested to visit the site before submitting offer to have an idea of the work involved I.e. type of soil, available space, clearances of the exiting line from nearby objects etc.
- 5. **Work Completion:**-The agency has to design the foundation of the tower suitable for the referred location and shall submit the same to this office with all details and drawings such as excavation details, concrete details, template drawing, RCC details, Bar Bending schedule etc. More ever, suitable tower is also be designed for this location. Accordingly the agency will supply erection drawing, BOM, Stub setting arrangement, tower spotting data etc. All these designs & drawings shall be submitted to this office within 30 days from the date of issue of work order.
- 6. **Penalty:**-The work shall be completed within **30 Days from the date of issue of work order** otherwise penalty @ 1/2% per week subject to max 10% of the order amount will be levied at the discretion of the Competent Authority.
