- i) Price bid only where in the rates/percentage should be quoted in figures as well as in words.

- 2) The work is to be completed within 15 days (i.e. installation of software etc.) from the date of handing over of site to commence the work, failing of which a penalty at ½% per week subject to the maximum 10% of the ordered value will be imposed.
- 3) The work should be strictly carried out as per specifications & up to the entire satisfaction of the Engineer-in-charge.
- 4) Payment will be made through First & Final bill/ R.A. bill basis at the discretion of undersigned.
- 5) The contractor will have to pay security deposit to this office equal to 5% of the ordered value.
- 6) The Security deposit will be refunded after 03 Months of completion of work as a Defect liability period.


