Sealed & super scribed quotation are invited, so as to reach this office on or before 15.01.2021 up to 17:00 hrs for Initial treatment & monthly weed control treatment for one year at 400/220kV GIS Substation Hinjewadi-III. detailed as per Schedule A and the terms & conditions given below.

### **TERMS AND CONDITIONS:**

- 1. Rates shall be quoted including all taxes as per the schedule "A" enclosed. Any changes must be brought out clearly.
- 2. Quotation should be submitted along with following documents on or before dt. 13.01.2021
  - i) Shop Act/ Udyg Adhar License/NOC of grampanchayat for shop .The NOC of gram panchayat should valid and recent one
  - ii) PAN No.
  - iii) GST Registration No.
  - iv) Valid pesticide/insecticide license from the competent authority for the work under subject.
  - v) Work experience of similar work
- 3. The right to place an order for Initial treatment & monthly weed control treatment or to cancel quotation with out assigning any reason is reserved by this office.
- 4. Payment will be made by NEFT/ONLINE payment.
- 5. No other charges except schedule will not be borne by the MSETCL.
- 6. MSETCL may, by written notice sent to the selected agency, terminate the work order and/or the contract, in whole or in part, at any time as per the requirement or change in circumstances in MSETCL.MSETCL reserves the right to cancel the remaining part and pay to the selected agency an agreed amount for partially completed services.

7. The contract will be for a period of one year or till the requirement exists, whichever is earlier. The contract will be automatically stand terminated as soon as the period of contract or contract value is over. No separate notice will be issued for the termination of the contract. Further, the MSETCL reserves right to extend the period of selected categories for more than one year (not exceeding maximum period of 6 months or 50% of contract value whichever occurs earlier) on the same terms and conditions. The successful bidder is bound to accept such extension orders.

### 8. Providing Services / Support

- i) The agency personnel shall be required to provide services/support as specified by MSETCL. In case any personnel of the agency is found engaged in doing any work other than the above or found not useful for the specified job, the agency shall withdraw him/her from service and arrange for replacement immediately at their own cost.
- ii) The agency shall be responsible for any damage to equipment's, property and third party liabilities caused by acts on his part of/ on part of its deployed manpower at MSETCL's premises. In case of any theft or loss of property due to negligence or carelessness of your personnel, agency will be fully responsible and you will have to make good of the losses so incurred to MSETCL, otherwise the same will be deducted from the security deposit or from the payments.
- iii) MSETCL stands absolved from any liability on account of death or injury sustained by the concerned personnel during the performance of this contract and also for any damages or compensation due to any dispute between the agency and its personnel.
- iv) The personnel shall maintain office decorum. They shall be courteous, polite and cooperative and able to perform the duties with due diligence. They must observe all the etiquette and protocol while performing the duty. The agency shall verify the character antecedents before deploying any person at MSETCL.
- v) Any extra expenditure for getting the work done from other agencies /open market due to the failure of the agency to provide support within the scheduled time as mentioned in the contract / other dues payable to the agency by raising claims.
- vi) MSETCL reserves the right to deduct amount from the bill as may be considered reasonable for unsatisfactory services or delay in providing of services. The decision of MSETCL will be final in this regard.
- vii) This contract is a contract for services and there is no express or implied relationship of employer and employee between agency's employees' representatives and the MSETCL.
- 9. **Penalty**: The agency shall provide the required service within the period specified in the requisition of the company otherwise the penalty of 0.5 % per week of the value of contract not provided in time will be levied subject to maximum 10% of order value. In case agency fails to provide service to the MSETCL, the contract to agency will be terminated and security deposit will be forfeited. Recovery will also be done for work got done from alternate sources at the risk and cost of the defaulting agency.

#### 10. JURISDICTION:

All the disputes arising out of this contract shall have exclusive jurisdiction of District court.

- 11. The bibber can visit site & be well aware of site location before participating in bidding process.
- 12. **Security:** The tenderer shall ensure that all his personnel, while in the premises of the company; comply with the company's rules and regulations regarding safety, security, discipline and good conduct.
- 13. Payment: The payment of initial chemical treatment as per Schedule A(1) will be made after satisfactory completion of work and receipt of bill certified by Addl.EE. 400KV S/stn Project S/dn Hinjewadi. The services to be provided shall be on monthly basis and payment will be done on quarterly basis i.e. 3 months is equal to 1 quarter. The. The payments to the agency will be made on quarterly basis after receipt of bill certified by Addl.EE. 400KV S/stn Project S/dn Hinjewadi.
- 14. **Security Deposit**: You will have to pay Security Deposit of 5% of the total contract value in favour of MSETCL for due performance of contract and the same will be refunded after six month of satisfactory completion of work .
- 15. AGREEMENT: Necessary agreement on a Rs. 500 stamp paper (work order amount limit upto Rs. 1 to Rs. 10 lakh) shall be executed by you at your cost within 10 days from the date of receipt of this work order. Until such agreement is made, neither company shall be liable to pay any amount to you nor you shall be entitled to claim any amount from the company. All the formalities required in connection with the execution of the agreement shall be completed by you in consultation with undersigned..
