- 1. Due Date:-** The quotation completes in all respect, duly sealed & super scribed should be submitted to this office on or before **Dtd. 25.01.2021 upto 18:00 Hrs** Positively.
- 2. E-quotation Fees:-** Agency should have to pay Rs. 105/- (Rs. 100+5% GST) against E-enquiry Quotation Fees by cash to Circle Office Karad & copy of the money receipt should attached with the quotation this office.
- 3. Estimated cost:-** The estimated cost is limited upto **Rs.02.00 Lakhs** Only inclusive of all taxes.
