 - (v) Payment of EMD Rs. 2000.00 to be made by bidder off-line only upto 14.00 hrs of 29/01/2020 in the office of EE(C), Dn., Nashik. EMD details Amount and M.R. No. should be super-scribed on the Envelope
 - b) Documents in 2nd Envelop:(Price Bid)

- 3) The work should be completed within 12 Months from the date of handing over the site to commence the work, failing of which a penalty at ½% per week subject to the maximum 10% of the ordered value will be imposed.
