- 1) The rates [percentage] should be quoted on Firm Quotation basis (Two Bid System only) including cost of materials, labours & T&P etc. required for execution of the work.

- (v) Payment of **EMD Rs. 2000.00** to be made by bidder off-line only upto 14.00 hrs of 29/01/2020 in the office of EE(C), Dn., Nashik. EMD details Amount and M.R. No. should be super-scribed on the Envelope

**b) Documents in 2<sup>nd</sup> Envelop:(Price Bid)**

- 2) The quantities enumerated in here attached Schedule B are approximate, however the payment will be made against actual executed quantities on site.
- 3) The work should be completed within **12 Months** from the date of handing over the site to commence the work, failing of which a penalty at 1/2% per week subject to the maximum 10% of the ordered value will be imposed.
- 4) The work should be strictly carried out as per standard specifications & up to the entire satisfaction of the Engineer-in-charge.
- 5) No materials will be supplied by the MSETCL for this work except materials as shown in Schedule A
- 6) Payment will be made through First & Final bill/ R.A. bill basis at the discretion of undersigned.
- 7) The contractor will have to pay security deposit to this office equal to 5% of the ordered value.



- 8) In case any accident occurred to the Contractor's labour/workmen during execution of work, the contractor will be fully responsible for all claims & compensation. No charge in any case will be borne by the MSETCL
