## **TERMS & CONDITIONS:**

- 1. **DUE DATE:-** The quotation completes in all respect, duly sealed & super scribed should be submitted to this office on or before **Dtd.03.02.2021 upto 18:00 Hrs** Positively.
- 2. E-QUOTATION FEES:- Agency should have to pay Rs.105/- (Rs.100+5% GST) against E-Enquiry Quotation Fees by cash to EHV O&M Circle Office Karad & copy of the money receipt should attached with the quotation this office.
- 3. **DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS :-** Please submit the following documents along with offer :
  - 1. Copy of the Money Receipt against submission of e-enquiry fees.
  - 2. Valid Electrical contractor license.
