## **TERMS AND CONDITIONS:**

- 1) The quotations should reach to this office on or before 03/02/2021 upto 16.00 Hrs. This office shall not accept any responsibility for late receipt of quotations due to postal delay.
  - a) Rate : The rate quoted shall be on firm basis and shall be inclusive of All taxes excluding GST.
  - b) All the taxes including wheel tax, town duties, comprehensive insurance and any other statutory tax applicable. (However the incidentals such as parking charges, toll/ entry tax etc will be borne by the user).
  - c) The services of the Driver.
  - d) Only Diesel shall be supplied by MSETCL.
  - e) The normal working duty of the vehicle is from 09.00 to 19.00 hrs or 08.00 to 18.00 hrs as fixed by vehicle incharge with one hour recess period for the Driver.

#### Vehicle / Registration : 2)

- a) The vehicle should be in good running & fairly comfortable condition i.e. tyre, all meters, cushion, wiper etc. must be in working and good condition.
- b) The vehicle must have RTO registration, requisite Tourist permit for travel in Maharashtra, GOA & Karnataka as per MSETCL requirement valid for the period of contract.
- c) The vehicle registration must be after 1<sup>st</sup> March 2015. However, preference will be given to latest model/manufacture.
- d) The vehicle must have comprehensive insurance policy Third Party Insurance will not be acceptable.
