## A. <u>Techno –Commercial bid:</u>

- 1. Valid shop act & establishment registration or NOC of Grampanchayat.

- 3. Valid GST registration certificate.
- **4.** Work experience certificate issued by the competent authority not below the rank of Executive Engineer of similar work & copy of work order for the same.
- 5. Scanned copy of EMD & tender fee receipt.

- 2. This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.

3. The technical documents should be submitted in the technical bid & commercial documents /offer/price bid should be submitted separately, in case both technical & commercial bid are enclosed in one envelope wrongly, the offer will be rejected.

### **Terms & Conditions:**

- 1. You will have to supply the material <u>within 15 Days</u> from date of issue of work order. Also you will have to pay 10% SD against this Supply work order.
