<u>7.Rate Validity:</u> The offer shall be valid for acceptance for a minimum period of 30 days from the date of submission of the offer. During this period no bidder shall be allowed to withdraw his offer. Such withdrawal during the said period shall result in the forfeiting of SD.

8.Period of Order: - The work is to be carried out within 10 days from the date of issue of Order.

<u>9.Document Authorization:-</u> All the supporting & accompanying documents shall bear the authorized signature of the Bidder, failing which the offer will be liable for rejection.
