Sealed & super scribed quotations are invited for the above said work on item rate basis. The lowest rate must be quoted subject to following terms & conditions:-

- 1) Due Date:-The quotations complete in all respects duly sealed & super scribed should be Submitted to this office on or before **04/03/2021** up to **14:00** Hrs. positively. If possible quotation will be opened on same day in office timing.
- 2) Quoted Rates:-The rates quoted by you should be excluding GST, charges shall be payable extra as per rules & regulations.
- 3) Security deposit:-2.5% in cash or FDR / D.D. of nationalized bank within ' 7 ' days from the date of issue of the Work Order & balance 2.5% Security Deposit shall be recovered by deducting through RA Bills, so that total Security deposit equivalent to 5% of the contract value is made up and held by the company as security deposit.
- 4) Validity Of Offer:-The offer should be valid for our acceptance for a period ' 1 ' year from the Due date of same.
- 5) The rates should quoted on, per day basis & the average Km/Ltr shall be quoted. Average diesel Consumption of vehicle provided by MSETCL should be minimum ' 16 ' Kms/Ltr.
- 6) No extra charges will be paid for vehicle driver, repairs, oil & all other expenses etc.
- 7) The vehicle should be in good condition & not more than 05 year old, should have valid T permit.
- 8) The period for hiring of vehicle will normally be ' 12 ' months or ' 255 ' days limited to work order value from the date of engaging of vehicle.
- 9) Vehicle will be utilized to run in Nashik, Ahmednagar, Jalgaon, Nandurbar, Dhule district as well as Mumbai & Pune. If required, the vehicle shall be utilized beyond jurisdiction of these districts.
- 10) If the performance and services given by the hired vehicle & Driver is not found satisfactory, The contract will be terminated without giving any notice at cost and risk of person contracting the vehicle and security deposit paid will be forfeited.

- 11) The hired vehicle must run on all types of roads. The condition of all tyres fitted to the vehicle Must be Good and serviceable Stephaney should be provided in the vehicle.
- 12) The responsibility of comprehensive insurance, PUC, taxi permit & RTO formalities will be with vehicle provider.
- 13) Payment will be effected on per month basis within reasonable period after recording in Measurement Book by concern officer in charge.
- 14) The rate should be quoted on firm quotation basis (two bid system only)

- 16) The monthly hiring Expenditure is restricted to Rs.50,000/-(Rupees fifty thousand only) including fuel (Diesel)cost.
- 17) The normal working hours will be between 09.00 Hrs. to 19.00 Hrs. However, in case the vehicle may be used earlier or beyond this period for which no extra charge will be paid by company.
- 18) If the hired vehicle is not made available on any working day/days without convincing reason or without intimation for which no charges will be paid for that day. The penalty at rate of 10% of the daily charges will be levied for such every day at the discretion of under signed.
