

Scaled and superscribed quotations are invited for Work of Refilling & reconditioning of Fire Extinguishing Cylinders at 400 kV R. S. Talandge as detailed in Schedule 'A' enclosed herewith subject to the following terms and conditions :-

- 1) The work to be completed within 45 days from date of receipt of work order.
- 2) Work shall be carried out as per Schedule 'A'
- 3) The rates quoted shall be exclusive of all taxes
- 4) Taxes shall be quoted separately.
- 5) Rates quoted shall be valid for the period of 90 days from date of opening.
- 6) 100% payment will be effected in reasonable time after completion of work.
- 7) You will have to pay security deposit of 05% of the total amount of the order.
- 8) You will have to execute agreement bond of Rs.500 & cost of bond should be borne by you.
- 9) **Following documents needs to be submitted along with bid online**
 1. Details of bidder such as name, address, contact number etc.
 2. Valid GST registration certificate.
 3. Copy of PAN Card.
 4. Shop act License copy.
- 10) **Penalty:** - Work shall be completed within 45 days from date of order. If agency fails to complete the work within scheduled time then penalty at the rate of ½% per week delay on unexecuted portion will be levied subject to maximum 10% of order value.
