TERMS & CONDITIONS :

- DUE DATE:-** The quotation completes in all respect, duly sealed & super scribed should be submitted to this office on or before **Dtd.19.03.2021 upto 18:00 Hrs** Positively.
- E-QUOTATION FEES:-** Agency should have to pay Rs.105/- (Rs.100+5% GST) against E-Enquiry Quotation Fees by cash to EHV O&M Circle Office Karad & copy of the money receipt should attached with the quotation this office.

23. **PAYMENT :-** 100% payment against the bills for the work actually carried out will be given to you after deducting necessary taxes & duties as per Govt. rule either by cheque or NEFT/RTGS.
