



ANNEXURE (S)
GENERAL TERMS AND CONDITIONS

- 1) Security Deposit: You will have to pay Security Deposit 10% of order value at EHV O&M Circle Karad within 7 days from the date of intimation. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized /scheduled Bank. The SSI units will have to pay security deposit as per statutory provisions. The security deposit will be refunded after satisfactory completion of the guarantee / warrantee period.
- 2) Guarantee Period: The material should be warranted by company for **Three year** from the date of installation against any manufacturing defects & will be replaced in case of defect arises in the warrantee period, should be replaced free of cost.
- 3) Delivery Period: The work should be supplied within **1 week** from the date of issue of supply order to this office.
- 4) Penalty: If you fail to supply the material in time, penalty at 1% per week or part thereof will be levied on you on the cost of material which are supplied late subject to maximum 10% of the total value of the this order, However due consideration will be given in lieu of penalty for the reasons absolutely beyond your control which documentary evidence will have to be produced by you.
- 5) Payment of Bill: Suppliers will be paid 100% payment of the contract price along with 100% taxes as applicable of each consignment by A./c. payee cheques against delivery. The bill should be submitted to this office in triplicate, accompanied by the S.R. Note of Consignee, certificates (if any), and advance stamp receipt. The Payment will be made with reasonable time by EHV O&M Circle, Karad.
- 6) Specifications: The materials offered should strictly conform to the specifications. If necessary, the material will be tested before / after delivery to ensure that it conforms to the specifications. If the same is not conforming, then the whole lot will be liable for rejection.
- 7) Income Tax & WCT will be recovered as per prevailing rates from your bill. You should mention PAN No., GST No. on your bills.
