
- 1] Scope of work: - Supply of L-Shape Executive Table as per attached schedule A herewith. The work is to be carried out as per instructions of MSETCL concerned authority.
 - 2] Security deposit: - The successful bidder will have to pay security deposit for amount of 10% of the total value of order i.e. **Rs. 3,573/-** by demand draft to this office, within 3 days of the receipt of work order. The SD will be refunded after the end of warranty period.
 - 3] Contractor shall furnish EMD amount is Rs. 500/- in the form of Cheque or DD in the name of "MSETCL Mumbai" or by cash along with the quotation and write M. R. No. along with vendor no. over the sealed cover of quotation.
 - 4] The bidder should submit the following documents/certificates (Self certified copies) with sealed quotations.
 - 5] The rates quoted should be on firm basis and inclusive of material required, T&P labour, Taxes and installation.
- Technical & Financial Criteria: -**
- a] Registration under shop & establishment Act. 1948.
 - b] PAN No. & income tax returns for Assessment Year 2020-21.
 - c] The bidder must have executed one such type of supply of furniture as mentioned in the enquiry of at least 50% of enquiring value during any one year in the last three years. The bidder should submit the performance certificate from the user in support of such works.
 - d] GST registration certificate, if applicable.
 - e] As per the circular published by corporate office in r/o exemption of EMD for SSI & NSIC unit, it is to indicate the following condition in field tender or enquiry is as follows: -

- 8] In case of under delay, the contract may be terminated by the competent authority as per general rules and regulations of MSETCL and the balance work, if any shall be got completed through separate contract at the risk and cost of the tenderer by forfeiting the security deposit.
- 9] The work should be carried out as per standard and to the satisfaction of the Engineer-In-charge.
- 10] All tools & plants required for the work shall be arranged by contractor at his own cost.
- 11] The quoted rates should be firm and should include all such as duties, all type of GST taxes, transportation etc. Also mention the SAP vendor number on quotation.
