Terms & Conditions:----->

- 1) The quotations submitted incomplete in any respect are liable to be rejected.
- 2.) Rates quoted should be inclusive of all taxes and labor cess@1%.
- 3.) Rates should be quoted separately on Annexure-A attached herewith.
- 4.) The period of contract shall be maximum up to 12 month.
- 5.) No extra charges for transportation, T&P and Labour, material etc will be paid, it will be arranged by you only.
- 6.) **Payment:** No advance payment will be made. 100% payment will be made on monthly basis within 30 days subject to availability of funds.
- 7.) Validity of your quotation should be at least 90 days. Copy of Valid elevator license issued by appropriate govt. Authority/Registration of G.S.T no./PAN No./Certificate of Bombay shop Act'1948 if applicable/ Inspection report duly signed by Addl.EE (Maintenance), SLDC, Airoli and details of Office address & Contact Phone number should be submitted along with the quotation.
- 8.) Completed Work order/work competition certificate issued by Govt./Semi govt./PSU Undertaking/reputed private listed companies etc. for Repair & maintenance of Lifts shall be attached along with your quotation. However the value of single work order

completed during any one of previous five financial year shall not be less than Rs. 89,156/- each in any case.

- 9.) The work shall be carried as per IS standards and procedure and as per directives of site in charge. This work order for comprehensive AMC of 2 no. Sleek elevator Capsule type Lifts at SLDC, Airoli shall be terminated in partial/complete whenever the work of new elevator installation get's started.
- 10.) The vendor has to carry out the inspection of 2 nos. capsule type elevators at SLDC, Airoli once in a year by Electrical inspector & charges for the same shall be included in quotation.**
- 11.) **Security Deposit:** You will have to pay security deposit amounting 5% of the value of the order within 15 days of receiving the order otherwise it will be deducted from the first bill. The SD will be refunded to you after satisfactory execution of the order. In the event of unsatisfactory performance of the contract, or non-compliance to T&C this amount will be forfeited.
- 12.) If any loss occurs to MSETCL property during execution of works, you should make it at good at your cost.
