**Sub:-** E-Enquiry for Fabrication of air conditioner bracket at 220kV Tilwani substation under EHV O&M Division Kolhapur.

Dear Sir,

Rates are called through superscripted sealed quotations **from 28.04.2021 to 04.05.2021 upto 15:00 Hrs** for the works mentioned in Schedule 'A'. The other terms and conditions are as mentioned below.

**Terms & Condition**

1. **PRICES:** - The rates will be accepted as per Schedule A rates with work at 220kV Tilwani substation under EHV O&M Division, Kolhapur.
2. **TAXES:** - Rates should be quoted in % basis only. Rates in Schedule A are Inclusive of all Taxes.
3. **WORKING PERIOD:** Work should be completed within 1 months from the date of issue of work order/LOI.
4. **VALIDITY OF OFFER:** Validity of work order will be 3 month from the date of issue of work order or exhaustion of work order amount.
5. **GUARANTEE:** - The works should be guaranteed against bad workmanship and manufacturing defects, for a period of 1 year from date of work completed and this undertaking may be sent along with the bill without fail. For any defects in workmanship/Manufacturer, you will have to give free service within 7 days from the date of intimation within guarantee period.
6. **Security Deposit:** - You will have to pay Security Deposit 3% of order value before issue of work order.
7. **Supervision of Work:** - The work shall be carried out under the Supervision of Sub-station in charge.
8. **Scope of work** – The work includes: as per schedule A & as per the instruction of concern substation In-charge. Transportation of material and expert manpower will be at your cost only.

9. Penalty: - In case of work is not completed as per schedule i.e within one month, the contractor shall be liable to pay penalty @  $\frac{1}{2}$  % per week subject to maximum 10% of order value.
10. You have to provide experts for this works.
11. All required T&P/ Manpower should be arranged by you.
12. You shall abide with all Govt. rules, regulations, status for this work including workman compensation act etc.
13. Workmanship and quality of Materials: - The workman ship and materials used for this work should be of best quality. The bad quality material will be rejected.
14. Agreement Bond: - You have to execute the agreement bond on Govt. Stamp paper of Rs. 500/-before issue of work order. Cost of stamp paper will be borne by you only.
15. Accidents:-Any accident to your labour during the execution of work, any loss/ damage to MSETCL property will be on your account and you will have to make it good at your cost.
16. Risk Purchase: - In case of failure to execute the order, the same will be purchased from other agency at our description and difference in cost will be recovered from the tenderer in addition to forfeiture of S.D.
17. Insurance:-The Insurance of your labour at your cost only. If fail the compensation / Claim arrears will be at your risk
18. MSETCL will not provide accommodation to your technicians / Supervisor, Labour, The transportation of materials / labours will have to be done at your cost.
19. Payments:-100 % payment against bill after satisfactory work completion.
20. SAP recording - SAP recording will be done by substation incharge on the basis of MOM within 3 days from the Dt of work done. Substation Incharge should take prompt action to process recording of SAP activities monthly towards executed work without fail. If delay observed then justification towards delay should be submitted along with bills.
21. In case you fail to carry out the work in part or full, the balance work will be carried out through other agency and difference in cost will be recovered from your bill, Security Deposit.
22. All disputes / differences arising under/ out of or in connection with the contract shall be subject to the exclusive jurisdiction of Kolhapur court only.

23. The MSETCL Terms and Conditions of work contract are applicable for this work.
24. 1% labour cess & 2% GST TDS will be deducted from your bills.
25. Monitoring of Order amount:- You should have to monitor work order amount. If the work exceeds beyond work order amount, excess amount will not be paid at any cost.
26. Undersigned reserve the right to cancel order in part or full at any time without giving in notice.
