**TERMS & CONDITIONS :-**

1. Name of Work Providing of LMV diesel Vehicle on hired basis for EHV Proj. Lines SDn, Beed.
2. The Vehicle should be in good running condition i.e. tyre, all meter, cushion, viper, etc must be in working & good condition, also the date of manufactured of vehicle within 10 years before date of Enquiry.
3. Monthly hiring expenditure should be restricted to Rs. 40,000/- including fuel. The fuel (diesel) will be provided by MSETCL. Average (Mileage per liter) should be at actual & not less than 12 km/Ltr
4. The Vehicle along with Driver should present at duty. The Driver has to maintain the vehicle diary daily.
5. During the vehicle on road if any problems related to vehicle arises it is owners responsibility.
6. Taxes & Charges shall be mentioned clearly. If not mentioned it will be considered inclusive of all taxes & charges.
7. Income Tax will be deducted at prevailing rate for every month.
8. The vehicle will be utilized on any day of the week & the same has to be made available with a short notice of the undersigned/officer in-charge. Further vehicle will be given off on any day without assigning any reason for which no charges will be paid for that day/days.
9. The quotations should reach to this office on or before **dt-10.05.2021 upto 13:00Hrs.**

11. Execution of agreement on Rs. 100 stamp paper is essential.
12. The following should be clearly mentioned on the sealed envelope :- "Quotation for providing of LMV diesel Vehicle on hired basis at EHV Line Proj. SDn, Beed"
13. Executive Engineer reserve the right to reject any or all the quotations without assigning any reason therefore.
14. The period of order is up to 12 months or exhaust of order value whichever will be earlier from the date of placement of order.
15. The driver should be free from alcoholic & smoking addictions.
16. Consuming diesel shall be supplied by Company.
17. The contract can be terminated by the authority at any time, without assigning any reason by giving one day advance notice.
