- 5. The Document of an offer shall be written legibly and free from erasures, overwriting or conversion of figures corrections where unavoidable shall be made by crossing out, rewriting, initialing and dating
- 6. You have to submit following Documentary Evidence of

 - c. Valid Electrical Contractor License
 - d. Registration Under Shop act
 - e. Bidder should provide the work completion / Experience Certificates against a contract for same type of work on 220/ 400KV lines or above voltage level in MSETCL for successfully completed work; received from authority not below the rank of Executive Engineer.
 - f. The agency should have minimum 5 Nos of Trained Technician from HLTC, Bangalore & sufficient supervisor & Electrical Engineer well conversant with Hotline work (Hot stick & Barehand Method) and Trained from NPTI, Bangalore or equivalent.

g. The agency should provide sufficient T & P list of (Ritz Make) Hotline tools application up to 400KV level. The T & P must be owned by the bidder and should provide the documentary evidence along with enquiry.

h. The agency should provide the list of min 5 Nos of POSITRON Kits (POSITRON make) The POSITRON kits must be owned by the Bidder and should provide the documentary

evidence along with enquiry.

i. The trained certificate from HLTC/NPTI or equivalent should be in the name of the firm.

7. GST & Labor Cess: Taxes & Duties will be applicable as per prevailing rates. Deduction of Taxes if applicable as per income tax Govt of India Rules.
