
TERMS & CONDITIONS: -

3. Quantities mentioned in Schedule - 'A' is approximate and are liable for variations. However, payment shall be made as per actual quantity executed and measured as per MSETCL's rules.
4. Quotations should be duly filled in all respect and signed, failing which it will be liable for rejection.
5. In case of any dispute, decision of the undersigned shall be final and binding on the contractor.
6. Taxes should be quoted distinctly, if any.
7. No material will be issued by the company for this work.


